### The Moora Early Childhood Development Centre

Will provide innovative approaches to early childhood health and education for the Shire of Moora and surrounding region. The new facility will have capacity for 55 children and the Centre remains on schedule to be open in mid-2024.

The Moora Early Childhood Development Centre is being built in Perth by Fleetwood Australia. Ground works are expected to commence in September with onsite construction following shortly thereafter. The project is funded by the Australian Government and Shire of Moora and will enable delivery of comprehensive services in a growing and supportive community.

## 2023/2024 Rates Information

### Message from the President...

On Wednesday 16<sup>th</sup> August 2023, Council adopted the 2023/24 Budget. Consistent with the finance model adopted in the 2022/2023 financial year, an overall rate increase of 5% has been applied, averaging \$127.05 annually, or \$2.44 per week.

This year's budget supports a significant capital works programme. The Wheatbelt Secondary Freight Route continues to expand sustainable economic growth for the region. The budget continues to focus on building & maintaining existing Council assets, including roads, community recreation facilities, water and sewer upgrades.

The Shire of Moora Council and its dedicated staff continue the pursuit of diversity and development of new economic opportunities that grow our Shire and Region through creating opportunities that attract new business and create an environment where families can thrive.
